## It's Springtime, Bike Riders!

Spring is here and it's time to take out the bicycles (please ignore if you are a 365 rider). The issues of theft and vandalism are always quick to follow. There are, of course, the outdoor racks that you can lock your bikes to, but if you paid more for your bike than I paid for my car (a good chance), you may want something more secure. There are enclosed bike lockers, and secured parking areas in some parking ramps for a fee (http://www.pts.umn.edu/bike/secure-bike-parking).

These options may or may not be optimal for all riders. After a discussion at the libraries' labormanagement committee, the subject of in-building parking, (whether in the office/cubicle or a designated area) was raised. Though the libraries do not have an explicit policy for bicycles, the Regents have policy language as to bicycles

(https://regents.umn.edu/policies/ordinances#ord-3). Article IV, sections 1 & 3 state that one cannot block or limit access to areas, or lock bikes to plants, etc.. What is more pertinent to this article is section 2, which states that "No person shall transport bicycles in University of Minnesota building elevators or operate bicycles in University of Minnesota buildings" (please do not try to challenge the latter through the grievance process). This language does not eliminate the possibility that members could discuss, with their building manager or supervisor, an indoor parking solution that follows the Regents' policies and is amenable to management.

Bicycle parking is a subject that effects our members, our AFSCME sister locals, Teamsters and other bargaining units, Civil Service and P&A. Bike riders are quite often passionate about their rights, and this makes for allies horizontally and vertically. Check with your department rules to see if there are specific rules for bikes, and if not, communicate with your fellow members and allies to examine the possibilities. And if there are members out there that would like to see a 3937 bike club to protect your rights and organize events, please contact the local (<u>afscme3937@gmail.com</u>) and we can put you in contact with like-minded riders.
